WCHC reserve the right to accept or reject any or all bids received and/or waive any defects or irregularities in the bidding documents, including additives and deductive and alternates in any order on any bid and award the contract to the bidder who, in the best judgment of the Department, has met all requirements and specifications with the lowest bid quotation offer.

A contract will be prepared and entered into between the WCHC and the awarded vendor after the bid result is announced. Bid award will be based on the following criteria; (a) quotation provided including the warranty and other attractions, (b) knowledge of the past performance which include quality of work provided, and (c) length of time to complete the job.
